Performance Returns

The Tosca Micro Cap UCITS Fund returned 0.57% in July (GBP Institutional share class).

Investment Objective & Strategy

The Tosca Micro Cap UCITS Fund is a fundamental, value-orientated strategy, applied to the opportunity rich UK micro cap segment. The fund will invest primarily in "micro cap" companies with a market capitalisation of up to £250m that are listed in the UK, and which are or are expected to become constituents of the FTSE Small Cap or the FTSE AIM All Share Index. The Fund is managed by Matt Siebert who, together with Daniel Cane and Jamie Taylor, support Martin Hughes in the management of the Toscafund mid-cap strategy. As such, the Fund represents an extension of the same investment philosophy employed in the award winning Tosca Opportunity and Tosca Mid Cap funds. The Fund targets an annualised return in excess of 15% (net of fees).

Manager Commentary

The fund was up 57bps in July aided by a takeover and strength in a core healthcare position.

July historically is when equity market activity starts to slow as people head to sunnier climes for their holidays. Whether a function of the restrictions on overseas travel or the need and desire to raise equity while the market appetite exists, UK companies have continued to tap investors for capital. In the month we participated in two growth capital raises for portfolio companies. Essensys placed £40m of new equity to accelerate sales, marketing and R&D into its core geographies, while K3 Capital delivered another small bolt-on acquisition, with plans to add others in short order and raised £10m to help fund those.

As has been well documented in the press, for every equity raise there has been a takeover. While many have been in the larger caps, we did benefit from Tencent bidding at a 43% premium for Sumo (+69 bps), the video games developer. We have held this name from its IPO in Q4 2018, since when the share

price is up five fold. The other main contributor in the month was Maxcyte (+106bps). This is the fund's largest holding at 5.9% of NAV. As with Tremor a month previously, Maxcyte sought to tap the US market by a joint listing of its equity on Nasdaq. The company offered out \$177m of new equity at between \$11.50 and \$13.50 a share. Demand was excellent, and as a result it was also able to tap the greenshoe and price towards the top end of the range (\$13). By introducing specialist US healthcare funds on to the shareholder register we believe that they are even better placed to market its core gene and cell therapy product.

Two other stocks worthy of mention for their contribution in the month were Kistos (60bps), the North Sea gas producer and Phoenix Copper (55bps), the US domiciled precious metals miner. Both reported encouraging updates in July pointing to medium term NAV upgrades.

Where we came under some pressure was from a pullback in certain Covid beneficiaries such as Halfords (-38 bps), UPGS (-33 bps), Fonix (-32 bps), Synairgen (-28 bps) and Virgin Wines (-19 bps). While disappointing, we remain supportive of all these companies and expect the micro newsflow to continue to be supportive.

Although we took a back seat in other transactions in July, including a number of IPOs, we have been able to invest more time underwriting our existing investments. For the first time in 18 months we were able to go out and visit companies. Our initial travels took us to Wales and the West Country. Here we caught up with Inspects, Loungers, SRT and Actual Experience along with a prospect company. The former two companies have come out of the pandemic in rude health and both are well set, in our view, to continue to beat market expectations. The latter two are very project dependent and, while newsflow has been limited of late, the discussions implied that they are both well placed as their end markets recover. We look forward to providing more colour on these names in the coming months.

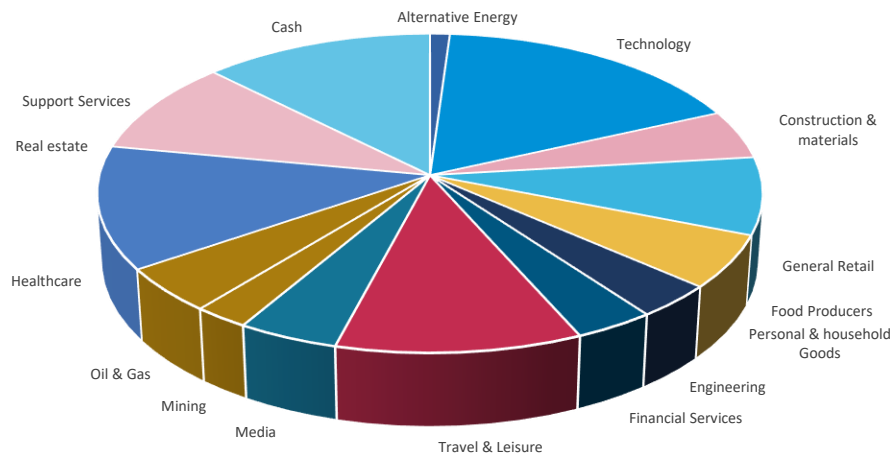

COMPOSITION OF FUND (Data as at 31 July 2021)

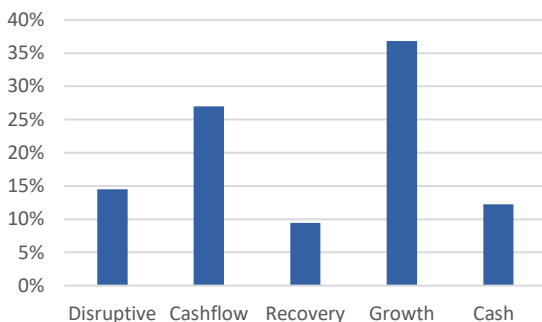
