### Objectives and Investment Policy

The investment objective of the Sub-Fund is to seek capital appreciation over the long term.

The Sub-Fund will invest in shares of companies which are located in the United Kingdom, listed on the London Stock Exchange and whose market value is between £100 million and £4 billion. To select investments, the Sub-Fund will assess, screen and rank a universe of companies on key factors, namely quality, value, growth and momentum. This investment strategy is called the QVGM+.

The Sub-Fund may use derivatives such as contracts for differences and warrants to make its investments. Derivatives may also be used for hedging purposes. A derivative is a contract the value of which depends on the change in price of an agreed-upon underlying financial asset, index or security and which gives the holder the economic effect of an investment in the underlying asset without actually having to acquire it.

Derivatives also enable the Sub-Fund to use leverage and to take short positions, which is part of its investment strategy. Leverage means the Sub-Fund will be able to create the effect of investing a greater amount than the amount subscribed to it by investors, while shorting means the Sub-Fund will make a profit if the value of an asset goes down, but it will lose money if the value of the asset goes up. When combined successfully, the Sub-Fund should be able to capture the returns generated from the shares held by the Sub-Fund while insulating itself from the general direction of the market as a whole.

The Sub-Fund may also invest in open-ended exchange traded funds and other open ended collective investment schemes which enable the Sub-Fund to achieve its investment objective. The Sub-Fund may also invest in cash

and money market instruments for cash management purposes.

You may sell your shares in the Sub-Fund on any day the banks are open in Ireland and the United Kingdom. You must submit your application to the Sub-Fund's administrator before 1.00p.m. three business days prior to the day on which you want to sell.

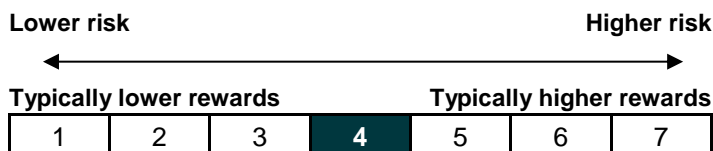
Your shares do not pay you income, but instead the Sub-Fund reinvests such income to grow your capital.

As your shares are in Euro and the Sub-Fund is valued in Sterling, forward contracts are used to attempt to eliminate the effects of changes in the currency exchange rates against Sterling.

The Sub-Fund is actively managed meaning that the investments are made on a fully discretionary basis. The Sub-Fund may measure its performance relative to the FTSE SmallCap Index and the FTSE AIM All-Share Index for reference or investor communication purposes. The Sub-Fund's performance is measured relative to the FTSE SmallCap Index (the "Index") for the purposes of the performance fees payable by the Sub-Fund. The Index does not define asset allocation of the Sub-Fund and depending on market conditions the Sub-Fund may deviate significantly from the Index.

Recommendation: the Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### Risk and Reward Profile



The risk category for this Sub-Fund is set at 4. It is calculated in line with EU regulations and is based on the risk limit for the Sub-Fund.

A **category 1** Sub-Fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited. With a **category 7** Sub-Fund, the risk of losing your money is high but there is also a chance of making higher gains. The seven-category scale is complex. For example, a category 2 Sub-Fund is not twice as risky as a category 1 Sub-Fund. The risk category shown is not guaranteed and may change over time.

When categorising the Sub-Fund it may happen that not all material risks were fully captured in the methodology. For a more detailed explanation of risks, please refer to the "Special Considerations and Risk Factors" section of the prospectus.

**Credit and Counterparty Risk:** A counterparty may fail in paying the proceeds of sale for assets sold by the Sub-Fund or may fail in delivering securities purchased by the Sub-Fund.

**Derivatives and Leverage Risk:** The Sub-Fund may use financial derivative instruments for taking short positions or for hedging purposes. Whilst this is intended to help the Sub-Fund to manage risk or to take investment positions more efficiently or effectively than could be done otherwise, derivatives can involve leverage and the risk of higher volatility, especially if some of the expected offsetting positions between long and

short investments do not work as expected, and the Sub-Fund may be exposed to additional risks and costs as a result.

**Short Selling Risk:** The Sub-Fund may create synthetic short positions through the use of derivatives. Short positions behave differently from long positions, and the Sub-Fund can for example come under pressure to close out short positions at short notice, and before an offsetting long position can mature. This can create unexpected losses from positions that might otherwise have been seen as low risk or well hedged.

## Charges

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
