### Performance Returns

The Cooper Creek Partners North America Long Short Equity UCITS Fund returned 1.5% for the month of April (IE00BG08P444) resulting in a net 2021 return of -1.6%.

### Investment Objective & Strategy

The Cooper Creek Partners North America Long Short Equity UCITS Fund seeks to generate attractive absolute returns, non-correlated to equity market performance by investing in a portfolio of high conviction ideas with a low net exposure.

Cooper Creek employs a catalyst-driven, value-oriented approach to investing in small/mid-cap, under-the-radar and/or out-of-favour North American companies with the potential for transformational change. There is a significant focus on generating alpha from single name investments on both the long and short sides of the portfolio.

### Monthly Commentary

In April, Cooper Creek Partners North America Long Short Equity UCITS Fund generated a 1.5% return, while averaging 2.6% net exposure, compared to the Russell 2000 and the S&P 500, which returned 2.1% and 5.3%, respectively. Over this period, the longs returned 5.1% and the shorts returned -3.6%.

Longs led performance in April. 6 longs, including two energy, two industrial, one business services and one technology position, each added 50 basis points or more to fund performance. The largest detractors were two telecom positions, each of which cost the fund 35 basis points on the month.

On the short side, the biggest winners were an industrial and a retail position, each of which added 35 basis points or more to fund performance, while a retail and a consumer goods short each detracted 50 basis points or more from fund performance on the month.

We enter May 90.5% long and 89.2% short/ 1.3% net long (19.8% beta-adjusted net long).

At the sector level, the fund's largest exposures are industrials, at 42.6% gross invested/ 5.8% net short; consumer staples, at 28.2% gross invested/ 7.6% net short; retail, at 26.4% gross invested/ 9.8% net short; technology/internet, at 22.1% gross invested/ 11.7% net long; energy, at 18.6% gross invested/ 16.3% net long; gaming/ lodging/restaurants, at 15.2% gross invested/ 3.3% net short; media/telecom, at 14.2% gross invested/ 8.5% net long, and business services, at 12.4% gross invested/ 8.6% net short.

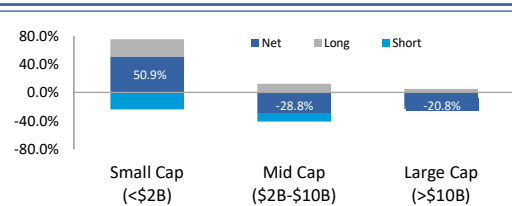

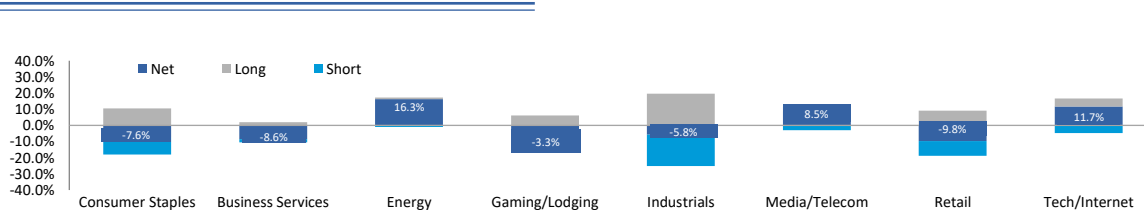
